Regent Velarde moved to approve the agenda as amended. Second – Regent Gurule. A roll call vote was taken. Regent Velarde – yes, Regent Lovato – yes, Regent Gurule – yes. Motion passed unanimously

IV. COMMENTS FROM THE BOARD

A. Board of Regents Subcommittee Reports

1. Housing Committee

Chairman Martin stated Regent Archuleta is not with us so we cannot have housing committee.

2. Audit, Finance, Facilities Committee

3. Academic and Student Affairs Committee

Regent Gurule stated she actually met with Mr. Baca yesterday and they only had one item to discuss and that is going to be discussed in greater length later in staff reports because it is an action item today.

4. Governance Committee

a. Presidential Evaluation

Mr. Baca states as the Board is all aware, the contract between the college and President Balderas calls for a presidential evaluation to take place once per fiscal year. Usually, we do that at this meeting. The purpose of the action item today is just to postpone that evaluation to either the next meeting or the August meeting, whichever is the board's pleasure.

Chairman Martin stated that he would like to see it at the next meeting if that is alright with the President.

President Balderas stated yes, there was a lot of, he guesses, unconventional issues, he would say, this, this, at the end of the spring, and we just thought it was more prudent to focus on those matters, impacting the institution campus-wide, and that we would, just be delaying by 30 days. We'll have a complete evaluation and criteria and material for the Board to consider in the next month. So, he thinks it was more prudent for us to focus on some of the issues that were impacting the college at the time. President Balderas thanked the Board.

Chairman Martin stated he would entertain a motion to defer the Presidential Evaluation until the July meeting.

Regent Velarde moved to defer the Presidential Evaluation until the July meeting. Second – Regent Lovato. A roll call vote was taken. Chairman Martin – yes, Regent Velarde – yes, Regent Lovato – yes, Regent Gurule – yes. Motion passed unanimously.

5. HERC Committee

Chairman Martin stated Regent Velarde and Chairman Martin met with the HERC this past week. They had Secretary Rodriguez give them a presentation about the upcoming constitutional amendment that's going to be on the ballot in November. The HERC had reached out to get legal counsel to see if we could actually, state an opinion on the upcoming...amendment which is going to decide how regions are selected in the future. It adds another level of bureaucracy. The legislature will be involved instead of just the governor in setting up a committee to pick... to choose regents. Our legal counsel informed us that we much like the presidents cannot tell people not to vote against it, we can just encourage them to vote. They did recommend that we maybe send some letters into the... letters to the editor, and as people to consider if they think this is the best... best way to change something that's been done since the...we became a state in 1912. Chairman Martin asked Regent Velarde for her thoughts as she was at the meeting.

Regent Velarde stated, yeah, it was a good conversation, good discussion, it's good to know, you know, what our options are, and as far as, you know, being able to speak about it. But yeah, I'm a lot in the idea that...you're right, an extra level of bureaucracy that, you know, it's already kind of bureaucratic enough, she believes. So, yeah, it was a good conversation, and the HERC meeting was just great as well to be able to move forward on our upcoming fall, fall symposium.

Chairman Martin stated yes, we have scheduled the Symposium for the 3rd and 4th of November in Portales and he'd hope that you all, if you could attend, it would be very worthwhile. We are going to be discussing what's coming up in the next legislative session, electing some new officers, so please put that on your calendar. The Secretary also did give us a handout, which I asked Ms. Pena to circulate to the rest of the board about some of the successes that we had. The presidents and all the colleges had at the last legislative session. Hats off to everybody for all that higher ed was able to accomplish, it was a very good session. Chairman Martin asked President Balderas if he agreed.

A. Celebrate Northern

We held our annual Juneteenth Celebration of Freedom last Friday in conjunction with Juneteenth New Mexico. I want to give special thanks to Sonya Smith, Former Cabinet Secretary of the New Mexico Department of Veterans Services, for serving as our keynote speaker and sharing why Juneteenth is so personal to her. Our Veteran's Center presided over the Presentation of Colors and raising the Juneteenth Flag. Mayor Dennis Tim Salazar read a proclamation in honor of Juneteenth, Matt Miller read a message from Teresa Leger Fernandez and Ben Ray Lujan sent a video message. Lazy Buffalo provided delicious barbeque and DJ Dave gave us great music.

We once again partnered with Western Colorado University to host the Trades Culture 2026 Boot Camp in Gunnison, Colorado. I want to thank Ralph E. "Butch" Clark for initially proposing this unique initiative and again fully funding it. III. Trades Culture 2026 Boot Camp

The Trades Culture 2026 Boot Camp, held in Gunnison, Colorado, May 31 to June 6, 2026, marked the second year of collaboration between Northern New Mexico College (NNMC) and Western Colorado University (WCU). The program was made possible through the generous support of Ralph E. "Butch" Clark, who fully funds this unique, technical trades initiative designed to connect NNMC and WCU students through hands-on trades education, cultural exchange, and collaborative learning experiences.

The 2026 Boot Camp brought together a diverse group of partners, including NNMC, WCU, Butch Clark, Hearth Design Build, the Coldharbour Institute, local tradespeople, and area business owners. The curriculum provided students with practical, real-world learning opportunities centered on renewable energy and construction trades.

Students participated in the installation of solar equipment on a Coldharbour Institute student housing facility, utilized the engineering laboratories and resources of WCU's Rady School of Computer Science and Engineering, fabricated project components, and met with local contractors to gain insight into career opportunities and industry best practices.

In addition to technical training, the Boot Camp emphasized team building, leadership development, and cultural enrichment. Students explored the natural beauty of the Gunnison Valley through hiking excursions in Crested Butte, participated in white-water rafting adventures, and networked with local trades professionals and business leaders. The week concluded with a graduation barbecue attended by students, partners, local tradespeople, and community supporters, celebrating the accomplishments, friendships, and professional connections developed throughout the program.

The Trades Culture 2026 Boot Camp continues to strengthen educational partnerships, expand workforce development opportunities, and foster cultural understanding while preparing the next generation of skilled trades professionals.

In attendance for the week of camp were, NNMTC Trades Electrical Instructor, Marvin Romero, and students, Nathaniel Romero, Elisha Arellano, Omar Valles and Dyon Herrera. Trades Chair, Joe Padilla, and Major Gift Officer, Judith Pepper, attended the graduation celebration along with Butch Clark, Western Colorado students and partnering organizations held in Gunnison on Saturday, June 6.

Since 2021, Mr. Clark has generously contributed \$491,891 to the NNMTC Technical Trades Department, helping strengthen technical education and workforce development. His commitment continues, with additional contributions expected in the years ahead.

Regent Velarde stated she wanted to give a shout out that, there was a third annual Energy Symposium in Espanola this last week and several of our students were there, via, she believes, a scholarship to attend and so she specifically sat with Cipriano and Lauren. 1. Nursing Department Request for New Course Fees

Mr. Baca stated as the Board has seen in the packet, there is a request for the nursing department to, create a \$242 course fee to be attached to the course Nursing 1119. This is a, licensing examination test prep course. It is part of the associate, in, degree program. It is not a required course, but it's growing in popularity. The course offers the students the opportunity to, just effectively prepare for their licensing examination. The course itself is taught, with... in conjunction with materials through a company called ATI, which is a leading test prep company. The purpose of the fee is to add another feature for students to be able to get individualized and direct feedback on how they're doing in their test preparation, where they are in that process, and what they need to do to bring themselves up to speed. As you all know, the nursing program has seen 100% passage rates on this exam for the last couple of years. So, Mr. Baca thinks that's in no small part to tools like this that are available to our students who go on to take that licensure examination. So, the request from the nursing department is to add this course fee to this particularized course. Mr. Baca emphasized again that the course is not necessarily required, so this is not necessarily a fee that all students have to pick up. But should they choose to participate in this test prep course, they now have the option to get this very personalized feedback. So, the recommendation to the Board of Regents is to entertain and pass a motion to institute the course fee.

Chairman Martin asked if there were any questions and entertained a motion to approve the Nursing Department Request for New Course Fees.

Regent Velarde stated these types of prep courses are very valuable. She took one when she had to take her licensure for engineering and it really did prep her and get her prepared for that test so she is in full support of that.

Regent Velarde moved to approve the Nursing Department request for new course fees. Second – Regent Lovato. A roll call vote was taken. Chairman Martin – yes, Regent Velarde – yes, Regent Archuleta – yes, Regent Lovato – yes, Regent Gurule – yes. Motion passed unanimously.

RE: Proposal for Campus Perimeter Fencing

Proposal: This comprehensive proposal outlines a strategic plan to install a secure perimeter fence at Northern New Mexico College (NNMC). NNMC recently allocated \$4,281,332.34 for critical campus security and accessibility upgrades. Incorporating structural barriers directly aligns with the institution's long-term campus environment and safety initiatives.

This project aims to establish a secure perimeter at the Española campus. It protects college assets, deters trespassing, and safeguards students, faculty, and evening staff. A structured barrier limits unwanted visitors while preserving an open, inviting campus atmosphere.

- 1) Perimeter Coverage: Aids in the repair of existing northern and southern property line chain-link setups and extend new high-durability fencing to fill perimeter gaps.
- 2) Material Selection: Heavy-duty ornamental wrought-iron or high-gauge coated steel to maximize deterrence and aesthetic cohesion.
- 3) Height Standard: 8-to-10-foot tall panels to prevent scaling attempts.
- 4) Access Integration: Strategic pedestrian and vehicle points automated for electronic key card access or automated lockouts.

This plan directly addresses modern campus safety requirements and aligns with current regional higher education capital funding recommendations allocated for NNMC's surveillance, access control, and emergency systems.

This initiative optimizes safety across NNMC's main Española Campus. The strategy shifts campus security from passive recording to proactive threat mitigation by integrating intelligent IP video surveillance with centralized cloud management and existing campus infrastructure. Install (109) Avigilon Security Cameras and upgrade the existing Avigilon Surveillance System across (16) buildings at Northern New Mexico College in Española, NM. While replacing dorm windows directly addresses physical building envelopes, its strategic impact extends to Northern New Mexico College's core mission and enrollment goals. Upgrading the South Dorm with energy-efficient units slashes building energy consumption, lowers operational costs, and mitigates long-standing deferred maintenance. For students, the project transforms aging residential rooms into comfortable, quiet, and thermally stable living spaces—a key factor in student satisfaction and retention. By carefully mirroring the historic architectural design, NNMC honours its cultural heritage while providing modern, sustainable facilities that welcome future generations of learners.

Describe the consequences of this project not receiving approval:

Deferring approval for the El Rito South Dorm window replacement creates compounding financial, structural, and operational risks for Northern New Mexico College. Continuously operating with degraded window envelopes subjects the facility to severe thermal energy loss, driving up campus utility expenditures while exposing the project to rising material and construction inflation costs. Beyond financial penalties, unchecked moisture intrusion through failing window frames poses an immediate threat to the building's structural assembly, elevating the risk of interior wall damage, wood rot, and mold remediation that will exponentially inflate future deferred maintenance liabilities. Most critically, delaying this work forces residential students to endure drafty, thermally unstable rooms and non-functional fixtures—substandard living conditions that directly compromise student satisfaction, safety compliance, and institutional retention efforts.

Furthermore, replacing degraded historic frames with modern, warranted units will reduce reactive facilities maintenance costs—such as seal repairs, hardware fixes, and water intrusion remediation—by over 50%. Overall, the project is projected to generate a net 10% to 15% annual reduction in the facility's baseline Operations & Maintenance (O&M) budget, redirecting operational funds back to core campus priorities.

Issue:

Board approval is required to update course fees for the Nursing and Health Sciences programs due to two specific operational changes effective for Academic Year 2026-2027. (See attached revised list).

Overview:

Malpractice Insurance Increases: Blanket student malpractice liability insurance for all nursing and health science students attending clinical practicum experiences is increasing from **\$15.00 to \$16.00**.

Drug screening is increasing from **\$50.00 to \$55.00** per student.

Uniform Fee Cancellation: The Associate Degree Nursing program will no longer purchase student uniforms. Students will buy their own uniforms directly. The department will only purchase iron-on institutional patches. Cancel the \$100 fee associated with NURS 1113L.
