## Student Success Tips: How to Succeed in 8-week Courses

With some planning and consistent effort, you can thrive in 8-week courses! Because of the accelerated nature of these shorter courses, it is essential that you follow these guidelines.

**1. Complete the Financial Aid Process:** Make sure your financial aid process is complete so you can register, purchase textbooks, and will not be dropped from your classes for nonpayment. If you are unsure, contact the Financial Aid Office at [finaid@nmmc.edu](mailto:finaid@nmmc.edu) or 505 747-2128.

**2. Register early:** Register for your classes as soon as possible so that you can prepare for the semester.

**3. Schedule carefully:** Take 2 first 8-week courses and 2 second 8-week courses for 12 credits. If you need 15 credits, add a 16-week course or a first 8-week course. Try not to take two challenging 8-week courses at the same time.

**4. Buy textbooks early:** Purchase textbooks two weeks before the semester begins so you will be ready for class! Also, buy second 8-week textbooks at this time to take advantage of financial aid funds. Click “Let’s Get Started” at this link, <https://bncvirtual.com/nmmc>, then enter your Eagle ID to see the textbooks for your required courses:

**5. Log into your Blackboard course on the FIRST DAY:** On the first day of classes, log in and carefully review the Start Here module, the Course Syllabus, the Instructor Information, and the Course Schedule.

**6. Be organized:** Create google calendar events for zoom classes, weekly deadlines, instructor office hours, exam dates, essay due dates.

**7. Keep up with the work:** Log in 3 to 4 times a week and specifically on the date each module opens. Review the weekly assignments. Break up the work and make a schedule to complete the assignments at least one day ahead of the

deadline. (You may need this window if something comes up!) Add reminders to your phone or google calendar so you do not get behind in your schedule. 8-week courses move very quickly and it is essential that you keep up with the work!

**8. Use the resources:** If your instructor provides samples and rubrics, read these carefully. Examine all instructions very carefully. Watch all posted videos. Read all assignments carefully. Carefully review all instructor emails and announcements.

**9. Ask for HELP:** If you do not understand an assignment, ask your instructor for further explanation. Follow the instructor’s guidelines for preferred communication (course messages, phone, email). Visit the instructor’s office hours to review assignments in progress or ask questions about difficult concepts. Ask questions during zoom classes.

**Seek help immediately.** Do not wait as 8-week courses move very quickly.

**10. Maintain excellent attendance and participation:** Attend and participate actively in all zoom classes. Thoughtfully engage in online discussion posts. Continue to log in several times a week and complete your work by the deadlines. Missing just one day is like missing an entire week of classes.

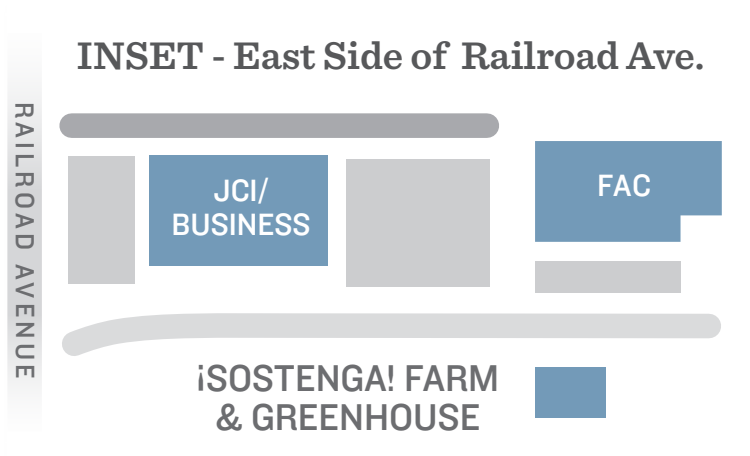
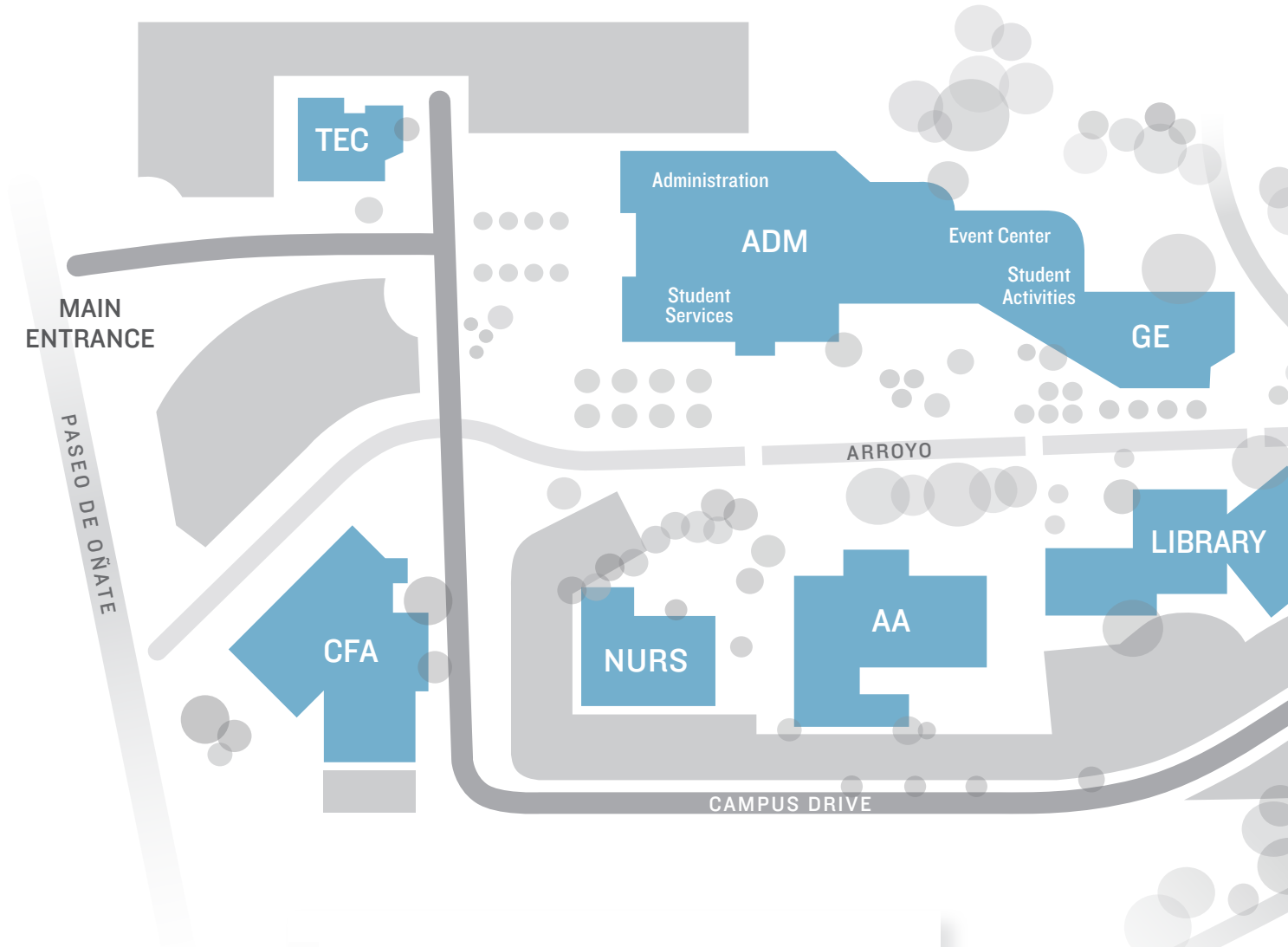

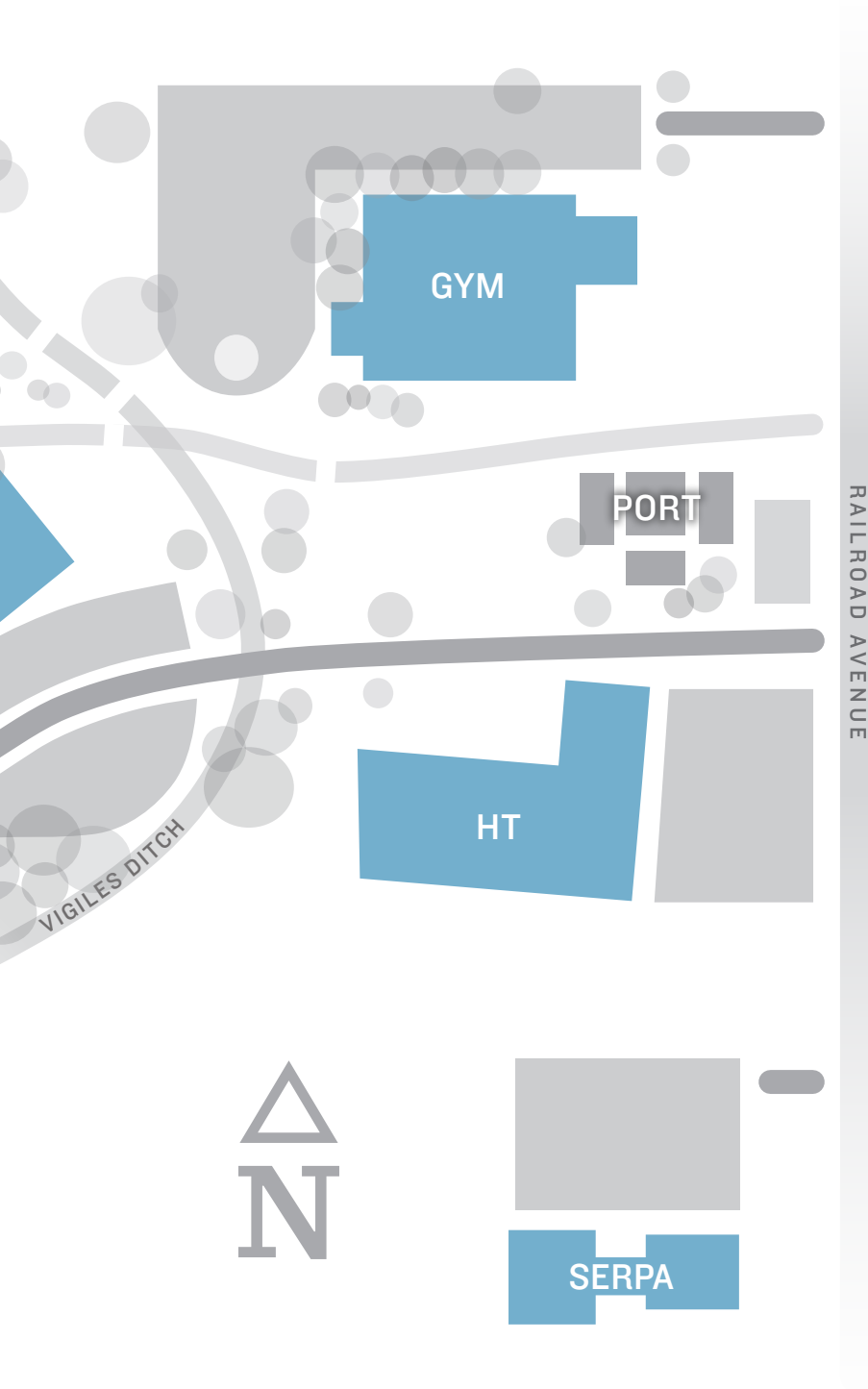

- **SUBMIT AN ONLINE APPLICATION** or download and submit a printed application to Northern's Admissions Office (address above).
- **SUBMIT TRANSCRIPTS** from high school & college courses (including dual credit) and any placement test scores you already have to Northern's Admissions Office.
- **TESTING:** The Accuplacer Placement exam is available online using zoom. The Placement exam is not required if you have recent high school transcripts (within the past two years) or other college entrance exams. ## Dual Credit Center / For students still in high school

### DUAL CREDIT CLASSES ARE FREE TO STUDENTS

Dual Credit fulfills the requirement that all high school students take one of the following courses to be eligible to graduate: honors, advanced placement, dual credit, or distance learning.

You may take as many courses as you wish, including summer classes, provided they do not interfere with your high school work and they are approved by the high school counselor, your parent/guardian, and the Dual Credit Center.

Remedial, developmental and fitness classes may not be taken for dual credit. Dual credit students are not eligible for scholarships or regular financial aid, but are automatically issued a Dual Credit Financial Aid Voucher at the bookstore for books, software, and other class supplies.

It is highly recommended that high school students take either the ACT, SAT, or ACCUPLACER placement exam. Scores help with placement of students in courses that align with their career and academic plans.

#### Dual Credit courses are offered:

- Via distance learning with college and other dual credit students.
- At a college campus with college and dual credit students.
- At the high school with an instructor certified to offer the course.

### HOW TO ENROLL IN A DUAL CREDIT COURSE

■ **APPLY:** First meet with your high school counselor and complete the dual credit application which will be submitted to the Dual Credit Center. Parent/guardian consent is required.

■ **TEST: You are strongly encouraged to prepare for and take a placement exam.** If you have not taken the ACT or SAT, those results should be submitted to the Dual Credit Center. If you have not taken the ACT or SAT, you may take the ACCUPLACER exam online or at NNMC. A study guide and practice test are available through the testing services webpage.

■ **REGISTER:** Complete a class request form in consultation with your high school counselor who will submit it to the Dual Credit Coordinator.

■ **COST:** Tuition and all fees are waived for dual credit students. High schools are billed for required bookstore purchases.

■ **BOOKS, ETC.:** Order your course materials and/or books online via the bookstore webpage, using the Dual Credit Financial Aid Voucher applied to your Student ID.

### REFUNDS

The schedule for deadlines to get a refund of tuition and fees is described in Northern's Catalog.

**1 Refunds are based on the date the notice (form or other written notice) is received,** not the date of transmittal to the College. For online drops, the computer records the date and time of activity.

**2 No refund is made on regular or late registration fees,** or in the case of disciplinary suspension or dismissal.

**3 If you are dismissed for falsification of records,** eligibility for refund will be entirely at the discretion of the College.

**4 In the case of a course cancellation,** all associated costs are refundable, including those which are normally non-refundable.

**5 In the case of loans, financial aid, or any other source of third-party funding,** any refunds are made to the lender or other appropriate financial aid program/entity, not directly to you. ■

## Financial Aid

The **Financial Aid Office at Northern New Mexico College** is committed to helping students navigate and understand the financial aid process and identify financial resources to help make their college education affordable. To apply for any type of aid including grants, scholarships, work-study and student loans, you must file a Free Application for Federal Student Aid (FAFSA).

### How to Apply for Financial Aid

#### FILE YOUR FAFSA:

The FAFSA is available at [studentaid.gov](http://studentaid.gov). Be sure to list Northern on the FAFSA using the Federal Code 005286. Continuing students who have filed a FAFSA in previous academic years should be able to file a renewal FAFSA online.

A renewal FAFSA allows the option to pre-fill most of the information from previous years. You must have your FSA ID available in order to pre-fill your new FAFSA.

#### CHECK YOUR FINANCIAL AID STATUS

You can check your financial aid status in myNNMC. Login to Banner, then click on the financial aid tab. Required documents can be viewed and downloaded by clicking on Eligibility and selecting the 2022-2023 Financial Aid Year.

#### HOW FINANCIAL AID IS PAID TO STUDENTS

If all requirements are met, your financial aid funds will be memoed to your student account prior to the start of the term. The memo can be used to pay for tuition, fees, and other non-institutional charges, such as books and supplies if purchased from the Bookstore@Northern.

If there is an excess of financial aid funds remaining after tuition, fees and books have been paid, then the remaining amount will be refunded to you by direct deposit into the bank account that has been authorized for this purpose. The refund aid typically occurs five weeks after the start of classes. Single semester loans will be issued in two disbursements, the second being after midterms. Disbursement for grants and scholarships will not be issued for late starting classes until approximately a week after the first date of attendance.

#### SUMMER FINANCIAL AID

## Substance Abuse Policy

Routine drug testing is not normally permitted, except for nursing students and members of athletic teams to meet the requirements of clinical contracts and/or NAlA regulations; however, if there is reasonable suspicion that a specific individual is in violation of this policy, that person may be required to undergo testing as a condition of continued enrollment as a student. This does not preclude the College, at its discretion, from conducting random drug testing programs for students participating in any athletic activities conducted or sponsored by the College. ■

NOTE: Class starting times below may vary for a particular class (or campus location). If your class starts, for example, at 0930 on MW, your starting time falls under "0900," and a starting time of 1230 would fall under "1200." Exams for classes held only one day per week can be located by finding the 2-3 day sequence on which your class is held; i.e. a Tuesday-only class would be with the "TR" combination at the appropriate time.

**SATURDAY/SUNDAY CLASSES** Sat/Sun classes will test during the first two hours of the last class period.

**DO YOU HAVE A DAY/TIME CONFLICT, OR A QUESTION ABOUT AN "ODD" DAY/TIME?** If the time of your scheduled class does not fit into any of the day/times above, check with the Registrar. Any personal conflicts with this schedule must be resolved with your individual instructor. The days/times for examinations are based on providing each student with a two-hour block for examination in each course, without having two consecutive classes testing back-to-back and without having any two examinations occur on the same day at the same time. If either the Provost or the President decides that some event warrants invoking an alternate exam schedule, make-up test days will be Sunday, May 12, 2024.
